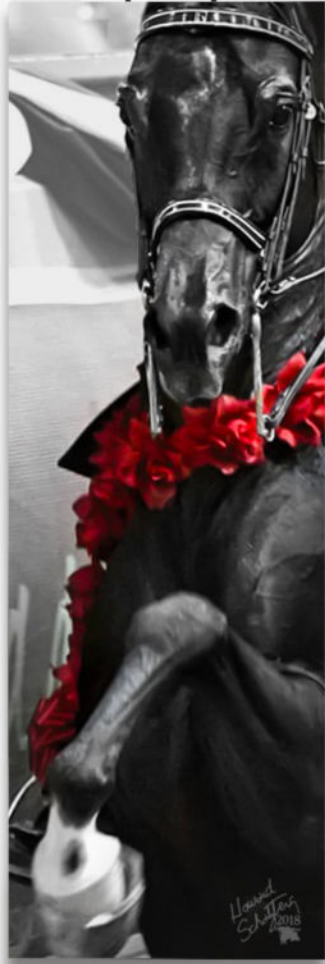

Any horse entered after this date will be charged a \$50 late entry fee. NO POST ENTRIES accepted for Dressage or Sport Horse In-Hand. A horse shall be in the name of the legal owner only. All entries should be accompanied by a copy of both sides of the horse's registration papers, copy of AHA, USEF and other necessary membership cards, copy of current negative Coggins, 14 day health certificate and USEF vaccine requirements.

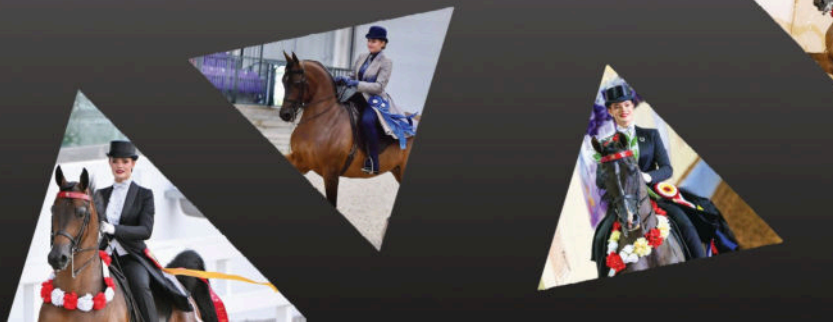

GENERAL RULES AND INFORMATION

1. Entries close March 11, 2025. No post entries for dressage or Sport Horse In-Hand. A wait list will be drafted in the event of a scratch.
2. ATTIRE: All entries must be suitably attired. Protective headgear per USEF Rules.
3. DISCIPLINE: Cruelty to or the abuse of a horse by any person in this show is forbidden. Excessive use of a whip on any horse in a stall, runway, schooling area, show ring or elsewhere on the show grounds before or during the show by any person constitutes a violation and renders the offender subject to a penalty.
4. All exhibitors & participants in this show are reminded that good sportsmanship & adherence to all rules are required. Any act of discourtesy or disobedience to the show officials will disqualify the horses from adjudication. Every person who participates is responsible for knowledge of & is subject to AHA & USEF rules. Questions not covered by the rules shall be referred to the Show Committee and their decision is final.
5. Every class offered which is covered by the rules & specifications of the current USEF Rule Book will be conducted & judged in accordance therewith.
6. Management reserves the right to remove a groom, horse, rider, driver, trainer or owner from this show without being liable for compensation or damages. Any offensive or abusive contact with any judge, official or management by any exhibitor will be cause for immediate removal from grounds and forfeiture of any winnings.
7. Barn Calls: It is the exhibitor's responsibility to be at the gate when the class is ready to go in. Every attempt will be made to keep exhibitors advised by the PA system, but **no** protests will be upheld based on PA announcements. Exhibitors should check in with the Paddock Master prior to class.
8. Two-minute rule: Classes will be called promptly. Two minutes will be allowed after the first horse enters the class, after which the gate will be closed. If it is impossible to keep from entering in successive classes, please arrange for a tack hold (5-minute max) with the Paddock Master one session prior to said class.
9. No person is allowed in the show ring during time of judging except the exhibitors or those having official duties to perform.
10. Vet Inspection: All horses are subject to physical inspection by the Show Vet as a safeguard against contagious disease. All horses must be serviceably sound, except Equitation Classes. In case of suspected unsoundness, the judge may, if they desire, have the animal inspected by the Show Vet & that decision shall be final. No exhibitor may use another vet's statement.
11. Grounds Regulations: All horses must have stalls. There is no showing out of your trailer. Stalls available Wednesday April 1, 2026 at 8am. Early Arrival Fee must be pre-arranged and will be charged to those who ship in before 4/1/2026. Monday \$100 per stall + \$3 nightwatch per horse, Tuesday \$75 per stall + \$3 nightwatch per horse. Late Departure Fee: Sunday \$75 per stall + \$3 nightwatch per horse.
12. No paint of any kind to be used on premises, no markings of any kind or disfigurements to the bldgs. Fences, etc. are allowed. No nails to be used on barns.
13. Washing of horses is permitted in wash racks only.
14. Trailers, cars or vans must be parked in designated areas only. No horses in RV lots.
15. All pets are to be always crated or on a leash while at a USEF Recognized event per USEF rules. No dogs on the arena floor.
16. Show management will assign stalls. Stall reservations may be made by sending the check together with entry blank and paid entries. Requests for stabling together must be made by sending reservations in together. Sorry, no additions to stalls reserved. Any stalls not used will be subject to a 100% cancellation penalty. The stalls are 12x12 permanent and made of concrete block, fully matted with fans and doors.
17. Feed and bedding are purchased directly through WEC. No outside bedding allowed! Bedding other than that purchased from WEC will be charged a \$30.00 removal fee per stall.
18. Manure MUST be placed in designated manure bins. NO Trash in Manure bins and NO manure in Trash bins!
19. Tack and horse stalls that are found with trash, personal items and debris are subject to a \$50 clean up fee PER STALL PER WEC. This does not include shavings/manure in horse stalls. This will be strictly enforced!
20. Regular class awards through 5th place will be given in all classes.
21. Prize money earned will be mailed to the OWNER of the horse within 30 days of the close of the show. The current address must be on the entry form and any checks returned will go back to OAHA.
22. Refund Policy: All fees will be refunded, except for office fees and credit card fees, prior to 3/11/2026 if received in writing. No refunds after 3/11/2026.
23. Substitution of officials: The show committee reserves the right to substitute judges or other officials if those named are unable to officiate.
24. Management reserves the right to limit the number of classes an exhibitor may enter. Management will limit the number of Dressage rides to a max of four combined discipline rides per horse/rider combination per day. Dressage ride times are limited and entries will be assigned on a first come-first paid basis. Once rides are full, a waitlist will be started.
25. A/HA/AA Dressage - In order to qualify for the championship classes, exhibitor must have ridden in a qualifying test of the same level the previous day.

26. Western Dressage - Classes with fewer than 3 entries may be canceled or combined with another class. Ride times will be available prior to the show. USEF membership is required for owner and rider. A WDAA membership is required or a non member fee must be paid. A USEF horse ID is required for open breed horses.
27. The Show Committee reserves the right to refuse entry to any person without liability or compensation.
28. In addition to the entries of persons suspended or expelled from the Federation, a Licensed Competition may refuse any entry of an exhibitor or the participation of any agent, trainer, rider, driver or handler who has shown an objectionable attitude or behavior at a Licensed Competition or towards its management, which management is able to substantiate, or previous unsportsmanlike behavior at a Licensed Competition which management is able to substantiate. (USEF GR 913.1)
29. Any protest must be filed in accordance with USEF Rules. Refer to Chapter 6, Rule GR603, USEF Rule Book.
30. Drugs & medication: Refer to USEF Chapter 4. Any horse doctored in any way, artificially, improperly, unfairly prepared or tampered with before entering the show will be disqualified.
31. Junior Exhibitors: An individual who has not reached their 19th birthday as of Dec. 1st. of the previous year.
32. RV spots available through WEC.
33. Arena 5 - 250 x 140, clay/sand mix footing; same for warm-up. North 3 & 4 - 299.5 x 180, fiber/sand GGT footing, same for warm up.
34. Lead-Line safety rules (USEF Subchapter AR-29 Section AR240 #4: (a) Saddle must fit rider, (b) Rider's feet must be engaged in the stirrups/iron, (c) Leading rein must be attached to a cavesson or a halter placed under or over the Bridle, (d) It is strongly encouraged that the rider wears protective headgear with harness secured which passes or surpasses ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag, & (e) Boots are required.
35. Sharps Disposal: – In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste. Competition management may fine any individuals including owners, exhibitors, trainers, or their agent up to \$100 for improper disposal of needles or other sharp disposable instruments.
36. A Current Competition Level Membership is required for all owners, trainers, riders/drivers/handlers or a Single Event Membership must be purchased for a fee of \$45 per person. A copy of your AHA membership verification should be included with your entry.
37. Each competitor is responsible for supplying management with correct applicable numbers (USDF, USEF, AHA) for horse, owner, rider and trainer before the day(s) of competition. Exhibitor will not be allowed to compete unless all membership information is provided.
38. Farrier: A Farrier will be available during the show. Chris Jones 251-583-2854.
39. Effective immediately, any competition with the start date of September 1, 2020 and later will be required to include the following Safe Sport statement in the Rules and Regulation section of the prize list: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.
40. **MOTORIZED VEHICLE STATEMENT:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles if they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will cause penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
41. **THERE WILL BE AN ADDITIONAL \$25.00 CHARGE FOR EACH INCOMPLETE ENTRY.** Entries lacking any of the above-mentioned will be considered incomplete and may be returned. Exhibitor packets will not be given to exhibitors until entry is complete. All entries must be accompanied by a valid check or credit card for the full amount of all fees made out to Ocala AHA.

AHA Academy Riding

Academy Class Specifications

The AHA Academy Riding division is designed to welcome new riders into the Arabian horse show world by offering a positive, low-pressure introduction to competition. Open to beginning riders of any breed, Academy classes provide an opportunity to build skills, gain confidence, and experience the joy of showing within a supportive and educational environment. Sections may be provided to allow multiple riders to show the same horse. ***Sections will be assigned at Instructors request.**

RIDERS: * Are encouraged to be in a professionally operated lesson program. (not required) * Are encouraged but not required to be an AHA member. First Year Academy Exhibitors are eligible for a FREE AHA Youth Membership. * Riding saddle seat suits, hunt coats and western chaps are NOT allowed * Riding pants, jodhpurs, breeches or colored jeans are considered appropriate. * A neatly fitted shirt or top is suggested. * A riding helmet is MANDATORY for riders 18 years of age and under and suggested for all ages. * Appropriate footwear with a small heel is MANDATORY. * Riders are NOT allowed to cross enter into any non-Academy riding classes and are ineligible to compete in Academy classes once they have shown in a full riding suit or in a non-Academy type show.

HORSES & EQUIPMENT: * Horses must be regularly used as lesson horses: While it is preferred that horses are owned by instructors, horses may be owned or leased by riders IF they are used and shown regularly by other riders as a lesson/school horse. * Any breed of horse is allowed, and registration is not required. Horses must be suitable to Academy division displaying good manners and a quiet disposition. * Any horse and rider that is deemed unsafe or is not abiding by these rules may be eliminated by the horse show management or judge. * A cut-back saddle for saddle seat, western saddle for stock seat, and hunt saddle for hunt seat are to be used. * Work bridles and bits, including snaffles are allowed, and running martingales are permitted and encouraged. However, the tie down martingales is NOT allowed. * Horses can cross enter in any Academy type class within the same show, but riders may not cross enter between the Leadline, Walk/Trot, or the Walk/Trot/Canter classes. * Show grooming is permitted, but not necessary as **HORSES ARE NOT TO BE JUDGED.**

JUDGING: * All Academy classes are to be judged on the ability of the rider to control and show their horse to its best advantage. and upon the riding skills of the rider. * Each class should be judged on the rider's basic equitation and horsemanship skills suited to the class discipline, with emphasis placed on the rider's ability to control the horse at all times, identify correct diagonals and leads promptly, and to control their horses rate in a consistent manner. * Riders should convey the impression of good posture, balance, and effective control while commanding proper speed of gaits and show ring placement. * Headers are allowed in the line up in all walk/trot classes. * **HORSES ARE NOT TO BE JUDGED,** only the rider's ability to control themselves and their horses while presenting themselves to their advantage. * Horsemanship Pleasure is meant to differ from the Equitation class in that it is judged more on the rider's ability to display their horse to its best advantage, communicating to the judge through their horsemanship and riding abilities that the horse is a pleasure to ride and can be guided and set up to show to its best advantage. * Classes may be split at the discretion of show management. * Entries into these classes must follow written Show Premium rules but are NOT AHA or USEF sanctioned classes.

AHA MEMBERSHIP STATEMENT

Each competitor (this includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches and the person(s) signing the entry blank) in an Arabian Horse Association recognized Arabian division, at the time of entry in a competition, must submit a copy of a valid AHA membership/competition card, join AHA or pay an AHA single event membership fee per competitor.

When an agent signs for the owner at an AHA recognized competition, both the owner and agent must be members of AHA or pay the AHA single event membership.

Single event membership is NOT ACCEPTABLE at AHA Regional or National competitions.

Exhibitors in Walk-Trot classes are exempt from AHA membership requirements at qualifying competitions, but must have an AHA membership with competition card at AHA Regional or National competitions.

Exhibitors in Lead Line classes or parents/guardians signing for minors are exempt from AHA membership requirements. (BOD 5/12)



USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULEBOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.



WDAA MEMBERSHIP STATEMENT

To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at any Federation Western Dressage Licensed Competition persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition. Exception: WDAA membership or non-member fee is not required at a Lite Licensed competition. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownership, only one owner need be a Member or pay a non-member fee. The competition is responsible for listing either the active member or the owner that paid the non-member fee in the results. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership.

USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

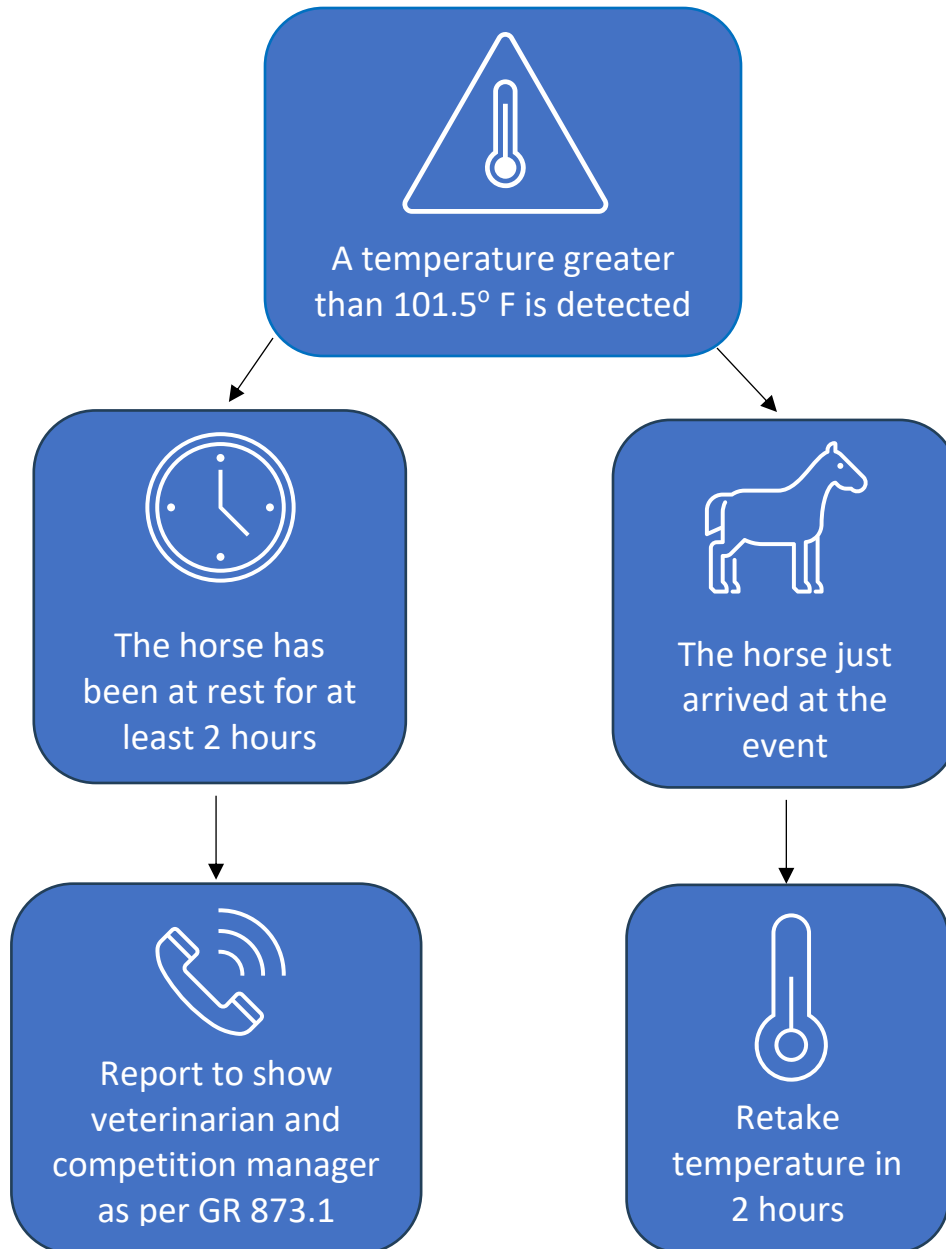

Alert: Mandatory Reporting of a Fever In a Horse at a USEF Competition (Temperature Over 101.5° F)



*Note: GR873.1 states "The trainer, as defined by Federation rules, or the owner if the trainer is unavailable, or the rider if the trainer and owner are both unavailable, shall notify the competition veterinarian and Competition Management as soon as possible but no later than two hours after the detection of any febrile horse or pony. A febrile horse or pony is one with an unexplained temperature above 101.5° F at rest (i.e. two hours after exercise or transport). If a febrile horse or pony is detected outside of competition hours or before the competition begins, notification must occur as soon as possible but no later than one hour after detection of the fever above 101.5° F".

AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION This document waives very important legal rights. Read it carefully before signing.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows: I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

I AGREE for myself, my heirs, executors, administrators, successors and assigns to release AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

Should a hearing be requested, I agree to accept AS FINAL the decision of the particular hearing body. I agree to release, hold harmless and not to sue AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Show Commission, Show Officials or any hearing body that relates to my qualifications or my horse(s) qualifications to enter the Competition or any results of the Competition.

I AGREE that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This AHA Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain effect.

I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
